


Mr. Michael K. Sullivan - Director, Technology Management, C&A Consulting LLC

He has designed and implemented IT Disaster Recovery for BETA Systems, co-authored BETA's back office Private Cloud solution (BETAHost), and architected and implemented the digital transformation of BETAHost application to support customers' real-time access to data and to design products that address customers' needs. Mr. Sullivan has architected end-to-end solutions, including mainframes, distributed systems, WAN, LAN and Windows servers, having led business and technology transformation from mainframe-only environments to a three-tiered solution to reduce costs, improve product delivery and scalability.
